For customers who have purchased the MaraX at an authorised Lelit retailer during the promotional period, register your product at <https://www.lelit.com/en-us/product-registration>, with the receipt/proof of purchase uploaded to the website. Details of the redemption process for the free Walnut Upgrade Kit will then be displayed for eligible purchases.

Exclusions
